### **1. OWNERSHIP**

- All goods are offered subject to availability, to ensure goods are available please pre-order.
  - All goods remain the property of Little Italy Ltd. until paid for in full.
- Acceptance of goods shall be deemed conclusive evidence of the buyer's acceptance of these conditions.

### **2. CANCELLATION AND RETURNS**

- We are confident you will be happy with your purchase. However, should you feel it necessary to return an item, we aim to make the returns process as simple as possible.
- If you are unhappy with one or more items, simply return them in the original packaging and we will give you a credit on those products or replace the item where possible. **Please note our office must be notified within 24 Hours of delivery.** In order to receive credit for damaged goods all goods must be returned within 2 days of delivery. Otherwise you are deemed to have accepted the goods.
- All such goods must be stored under appropriate conditions and be available for inspection. No liability other than the value of the goods is accepted for non-delivery, or late delivery.
